This was a common answer among those being recalled

We work in a non-partisan environment. We set our individual views aside. We look to experts, we implement best practices, we utilize researched strategies to address community needs.

The question then becomes:

What experts? Who decides what 'community needs' should be addressed, and where are your 'best practices' coming from? "Experts" in CRT, SEL and the 1619 project are finding their way into our schools. Very recently a LinkedIn ad was put out for an SEL advisor for Grandville Schools. Who makes these decisions? The 'community needs' being addressed are being decided by those with hidden agendas. All we're asking for is simple answers to simple questions, so we know where each board member stands.

I pointed out to all board members "We work as a non-partisan group and set individual ideologies aside" is a disingenuous statement. It's also condescending and should give everyone pause. Members that answer this way either have no concept of deductive reasoning (which is troubling) or they think so little of your ability to think logically they feel you'll fall for platitudes. Yes, boards work as a 'group', a group of individuals who all have a vote. If all those individuals have an ideology that conflicts with most Grandville residents, policies will be implemented that do not reflect the views of our community.

I further pointed out, if individual ideologies don't matter in entities that function as a group, then there should never be any questions posed to Supreme Court candidates. It is the exact same principle.

Conclusion:

Christy doesn't want to answer our questions. One can only speculate why. Rest assured there is a reason.

I suspect its because she knows her views conflict with most Grandville parents. If she felt she would gain widespread support by answering these questions, she would have taken the time to respond.

You as parents of students in Grandville schools DESERVE to know where your board members stand on topics important to you. Please hold them accountable. Even if you don't sign the petition to remove them, email them and ask them where they stand on matters important to you!

In an effort to eliminate ambiguity in vernacular and make answering as simple as possible a YES/NO questionnaire was sent to the three members being recalled. That email and those questions are below. No one has responded.

Good morning Kim, Jason and Christy, This should take a grand total of less than 10 minutes.

Because it is you three who are up for recall I'm going to limit this request to you. I apologize for my persistence, but it would seem none of you believe you have any individual input into the direction of the board. That stance defies logic. I truly am looking to spread the truth about what you believe regarding topics I addressed. I view truth as the anecdote to misinformation. I would hope you agree.

To all of you I state again, I appreciate your service. Christy I do appreciate you taking time to answer even while potentially welcoming a brand new grand baby to this world. I pray all went well. I recognize your years of community service and the visibility of your 'Be Nice' project. Please don't assume I understand the import you attach to "Be Nice" when it comes to questions I ask. "Be Nice" may address some of my questions, but I don't have enough background to assimilate that.

While I would love to believe our board works in an ideologically and politically agnostic environment, human nature tells me this cannot be true. As I stated in an earlier email, if Supreme Court candidates are pressed for ideological stances, and they are dealing with matters of interpreting Constitutional Law, most certainly board members should expect to be questioned about their personal views on subjects important to the community.

I have purposefully tried to stay away from harsh or adversarial language as I truly believe we can disagree on major topics without being disagreeable. Your answers thus far are forcing me to at least be very forthright. Each of your answers have been extremely political (by political I mean having no substance), defy basic logic, and cannot be interpreted on either side of any issue. Being recalled, I would think each of you would welcome the opportunity to make clear your positions on topics of importance. The results of our exchanges so far trouble me.

Buck, whose father was the City's longest serving Mayor. The Bucks loved Grandville and she too found
